President's Report

Dear Friends and Neighbors

I hope you and your family are doing as good as can be expected during these strange and trying times. As you know, we have been unable to communicate with you through our newsletter over the last few months due to the limits on nonessential business. Thus, we have some catching up to do as well as some important new information to pass along.



Most of this newsletter is devoted to recognizing our champions at the 2020 legislative session and holding accountable those legislators and other officials that unnecessarily imposed austere and callous legislation harmful to retired public employees and to our state. We hope all RPENM members and their families use this information to inform how you vote in the upcoming primary election as well as in the general election this Fall, and beyond.

Our legislative focus for the 2020 legislative session was trying to defeat a bill (SB 72) that severely curtails retirees' COLA benefits. We stopped an almost identical bill in the 2019 legislative session, but we had a difficult challenge in 2020 as Governor Michelle Lujan Grisham created a phony task force to "study" the issue and make recommendations. For clarification, SB 72 suspends the COLA benefit for most retirees for three years and likely significantly reduces the COLA benefit moving forward. Without going over the numerous objections we raised during the task force process and 2020 legislative session, RPENM believes we made a compelling case against this legislation. We had strong academic, economic and public policy arguments supported by reports from the prestigious Brookings Institution and others that affirmed our position. I encourage all RPENM members to review these materials available on our website, rpenm.org.

As you are aware, retirees reluctantly agreed to a thirty-three percent reduction in the COLA benefit several years ago to help improve and sustain the overall PERA system. There were also supposed to be regular increases in the contribution rates for current employees as well as other structural changes to improve

PERA, but those changes only lasted a short time or were never implemented. The primary long-term change that went into effect and became permanent was the significant reduction to the COLA benefit.

Although politicians such as Michelle Lujan Grisham promised not to raid retirees' COLA benefits during their campaigns, that's exactly what Governor Lujan Grisham and many legislative leaders did during the 2020 legislative session. RPENM vehemently opposed SB 72 as unnecessary, poorly thought-out, and bad public policy, but we ultimately narrowly lost this battle in both legislative chambers. During the lengthy process that included the task force, RPENM and our allies were able to make some important changes to help protect retirees from this poor legislation. First, RPENM was able to change the legislation to include a 13th check concept. While the COLA will be suspended for three years, meaning that your COLA benefit will not compound over the next three years, most retirees will receive a 13th check equivalent to two percent of your current pension for the next three years. Also, retirees with a pension less than \$25,000 and retirees 75 years old and above will continue to receive a COLA benefit that increases to 2.5%. These are important and helpful changes that RPENM and our allies fought hard to secure in this process.

Nevertheless, we must recognize and thank our

champions during the 2020 legislative session as well as hold our legislative opponents accountable. As many of you may know, my public service career was as a Game and Fish Officer and I am still happiest when I'm on a horse out on the range. I guess I'm an old cowboy at heart. I also enjoy a good western and one of my favorites is the old Clint Eastwood classic, The Good, the Bad and the Ugly. Well, the title of this movie pretty much describes our legislators and other officials during the 2020 legislative session. Obviously, the most vociferous, strident and fervent proponents and sponsors of this hurtful legislation are The Ugly. Other legislators that went along with this harmful legislation are The Bad and our champions and supporters are The Good. I hope you enjoy and understand that's how RPENM has decided to describe our legislators in the following pages of this newsletter.

Thank you for your dedicated public service, membership and hard work on behalf of RPENM. I hope you and your family stay safe and remain strong in these difficult times.

Legal Update

There are two very brief legal updates. First, we have some news regarding our current lawsuit against the PERA Board, PERA Executive Director Wayne Probst and PERA Chief of Staff/General Counsel Susan Pittard. This lawsuit was filed in federal court to remedy a situation many of our members believed to be highly unethical and illegal. This involves the extraordinary and unprecedented pay raises at PERA for an elite group of employees over several years during the exact same time senior PERA staff are demanding cuts to retirees' modest COLA benefits. We believe this unconscionable behavior needed a strong response and RPENM filed this lawsuit last year.

Unfortunately, we drew a bad hand with the assignment of the judge in this action and we recently received even worse news when this judge issued an unprecedented. overreaching and unbelievable opinion. The judge granted the defendants' motion for a summary judgment, dismissing our federal lawsuit. As we strongly believe in our case, the RPENM Board of Directors has decided to appeal this decision to the United States Tenth Circuit Court of Appeals. This is a long and arduous process that will require significant financial resources, but our Board believes this is the right thing to do and we will always look out for our members' best interests and never back down. Even when the odds are against us, just like Clint Eastwood did in his most memorable roles, we will fight for you!

The Board of Directors has also agreed to explore potential new legal claims that may be viable from issues that arose in the 2020 legislative session. The Board has asked our attorney to review several key issues and provide us with an opinion whether there are legal options regarding the legislation and/or process during and after the 2020 legislative session. We hope to have some information in the coming weeks regarding these matters and the Board will consider all options.
