#### Did You Know?

Retirees are neither equally represented, nor proportionally represented on the PERA Board.

The PERA Board is a 12-member board. It is composed of eight (8) members that are current working state, municipal and/or county employees, two (2) retirees, plus two (2) Ex-Officio positions, the NM Secretary of State and the NM State Treasurer.

The composition of all PERA working and retired membership is: approximately 40,000+ retirees and approximately 50,000+ working members. Retirees represent 44% of the total number of PERA members while current working employees represent 56%.

Within the 12 member PERA Board, WE RETIREES only have a 17% representative body. The current working members have a 66% representative body and the State of NM has a 17% representative Body! This is a lopsided representative body to say the least.

#### Did You Know?

Throughout the past year, the PERA Board has been discussing pension reform, including modifying your COST OF LIVING ADJUSTMENT (COLA).

Although, there are two Retiree Representatives on the PERA Board. Their voice is overshadowed by the overwhelming non retiree majority of the PERA Board. We reached out to our two NM Gubernatorial Candidates and asked their thoughts on protecting the Cost of Living (COLA) for PERA retirees.

RPENM cannot endorse any one candidate for political office, however, we can ask questions and inform our members of their answers. Remember NM PERA RETIREES: Be Informed, Take Action, and Vote!

The following is the response that we received from Michelle Lujan Grisham's campaign:

#### **Gubernatorial Candidate - Michelle Lujan Grisham**

"Our retired educators and state employees have made their full contributions to their pension plans and deserve their Cost of Living Adjustments. Moreover, it is critical that we continue to retain and recruit quality educators and cutting current and future benefits is NOT the way to do that. Our educators deserve a pay raise, not a pay cut. New Mexico has stagnated economically under eight years of the failed Republican leadership of Susana Martinez and our pension problems are just the latest evidence of that. Moody's specifically cites a New Mexico "economy that has lagged the nation's, below-average wealth levels, and financial reporting practices which, while improving, are weaker than typical for a U.S. state." To punish our PERA retirees

and our current and future educators and employees for the failure of New Mexico's state government during the last eight years is dead wrong."

Howie and I have detailed economic plans that will help put us on a strong financial path, diversify our economy, and create more private sector jobs. The Legislature has been conducting hearings this summer on the status of our pension funds and I look forward to working with them to ensure the long-term sustainability of those funds. However, I do not believe that New Mexico needs to eliminate our defined benefit system for current or future educators and state employees and opposes any reduction in cost of living adjustments."

RPENM could not obtain a response from Steve Pearce's campaign, however, the following excerpts were taken from the Albuquerque Journal article (Candidates differ on state pensions) written on Wednesday, August 1, 2018. Written by Dan Boyd.

#### **Gubernatorial Candidate - Steve Pearce**

Pearce a Republican who will face Lujan Grisham in the November general election, said pension benefits and eligibility guidelines for those nearing retirement should be left alone, bus said workers near the start of their careers should expect changes. That could include having to pay more money into their retirement accounts to maintain current benefit levels. He also suggested possible changes that could make the pension function more like the retirement systems used by many private companies.

"Pensions in the private sector transformed significantly over 20 years ago," Pearce told the Journal. "Government pensions have stayed generous and lagged many changes. At a minimum, new employees coming into the government workforce are going to have a very different system. Employees many years away from retirement are going to have to see significant changes."

"All elected officials should exit the pension system immediately, and their elected service should not support or contribute in any way to pension benefits." Pearce said. "This won't solve the crisis, but it is a sign of both sharing the pain and leadership."


